PDPM Transition Readiness: Mapping a Successful Route to the New Payment Model

This 6-hour workshop will review fundamentals of the Patient Driven Payment Model (PDPM) effective October 1, 2019 and assist providers in preparing for a successful transition to the new SNF Part A reimbursement model. Emphasis of this training will be developing a deeper understanding of the payment model and the impact on interdisciplinary team operations with focused implementation guidance for a step wise facility action plan to guide an effective transition.
